## NOTICE OF RACE

### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 No national prescriptions will apply.
- 1.3 If there is a conflict between languages the English text will take precedence.
- 1.4 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions that will be on the official notice board located in the club-house lobby.
- 1.5 Appendix T will apply.

### 2 ADVERTISING

Competitor advertising shall comply with RRS 20. Boats may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.

### 3 ELIGIBILITY AND ENTRY

The regatta is open to all competitors born from 2005 to 2011 in "Optimist" class. The competitors will be classified as follows: boys and girls, born in 2005 – 2011 – overall ranking, boys and girls born in 2009 – 2011 – junior class.

Eligible boats must enter by completing the form during the onsite registration.

The regatta is open for the competitors

"Cadet" – boys and girls born in 2003 – 2011

"Laser 4.7" – boys and girls born in 2003 – 2008

"Laser Radial" – boys and girls born in 2000 – 2006

"420" – boys and girls born in 2002 – 2008

### 4 SCHEDULE

- 4.1 Registration, measurement and inspection:  
01 September: from 12:00 to 16:00
- 4.2 Dates of racing (TBD as soon as the dates of Eastern Economic Forum and Tall Ships Regatta 2020 are announced):

- 4.3 Number of races:  
Three races per day are planned for each class.

### 5 MEASUREMENTS

Each boat shall produce a valid measurement certificate. Measurement checks may be carried out before or after racing. All the equipment may be measured.

## **6 SAILING INSTRUCTIONS**

The sailing instructions will be available upon registration.

## **7 VENUE**

**7.1** Attachment 1 shows the location of the regatta harbour.

**7.2** Attachment 2 shows the location of the racing area.

## **8 THE COURSES**

The course to be sailed will be detailed in the SIs.

## **9 PENALTY SYSTEM**

**9.1** Discretionally penalties may be applied as specified in the SIs.

**9.2** Appendix P RRS will apply. Protest Committee will be appointed by the OA.

## **10 SCORING**

**10.1** The scoring system is the Low Point System of Appendix A.

**10.2** 2 races are required to be completed to constitute a series.

**10.3** When 4 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

## **11 SUPPORT BOATS**

Support boats may be provided on agreement with the OA.

## **12 BERTHING**

Boats shall be kept in their assigned places while they are in the boat park.

## **13 PRIZES**

Prizes will be given as follows: medals and trophies for boys and girls scored 1st-3rd in both overall ranking and junoir division in Optimist class and boys and girls overall ranking in other classes.

## **14 DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## **15 DAMAGE DEPOSIT**

**15.1** An initial damage deposit of 200 \$USD shall be paid by cash at registration, unless extended by the OA. This deposit is the maximum payable by the competitor as a result of any one incident.

**15.2** If a deduction from the damage deposit is decided by the OA, it may require that the deposit be restored to its original amount before the competitor will be permitted to continue in the event.

**15.3** Any remaining deposit after the event will be refunded within 10 days after the event.
